# **MINUTES**

### FINANCIAL REPORT

Chief Dockery presents the Financial Report for the month of September, with a target of 75% range. On the first page, Medical Equipment Maintenance and Repair, we are over but we had an unexpected charge from last year that was added to this year. This will be addressed when I present the amended budget next month.

Chief Dockery continued, on the second page, Engine 111, is at 235.15%. We knew this was going to happen being that we had \$23,000 of work done on the engine. The funds will be moved over from the Bond Surplus into the General account for that.

Medic 112 is at 103%. We had issues with airbags, air pump and the turbo. We just got it back from getting the repairs.

Fire Prevention is at 93.85%. This is for the year, we will not have anything added to this.

Mr. Trascher thanks the Chief and Mrs. Blackwell asked for any other questions. With no questions we move to the EMS Report.

## **EMS REPORT**

For the month of September, we brought in \$31,208.90. As of last month, we are plus \$16,254.31, ahead of what we budgeted for the year and we have a couple more months to go.
